

# **LRQA Independent Assurance Statement**

Relating to NISSIN FOODS HOLDINGS CO., LTD.'s Social Data for the fiscal year 2025

This Assurance Statement has been prepared for NISSIN FOODS HOLDINGS CO., LTD. in accordance with our contract.

## **Terms of Engagement**

LRQA was commissioned by NISSIN FOODS HOLDINGS CO., LTD. ("the Company") to provide independent assurance on its social data disclosed in Sustainability page of its corporate website and NISSIN FOODS Group Sustainability Report 2025 ("the report") for the fiscal year 2025(from 1 April 2024 to 31 March 2025), against the assurance criteria below to a limited level of assurance and at the materiality of the professional judgement of the verifier using ISAE3000 (Revised).

Our assurance engagement covered the operations and activities of the Company and its consolidated subsidiaries in Japan<sup>1</sup> and specifically the following requirements:

- Verifying conformance with the Company's reporting methodologies for the selected datasets:
- Evaluating the accuracy and reliability of data for only the selected indicators listed below:
  - Lost-Time Injuries Frequency Rate <sup>2</sup> (Employees <sup>3</sup>, Contractors)
  - Number of fatalities in work-related accidents 4

Our assurance engagement excluded the other data and information of the Company's suppliers, contractors and any third-parties mentioned in the report.

LRQA's responsibility is only to the Company. LRQA disclaims any liability or responsibility to others as explained in the end footnote. the Company's responsibility is for collecting, aggregating, analysing and presenting all the data and information within the Report and for maintaining effective internal controls over the systems from which the Report is derived. Ultimately, the Report has been approved by, and remains the responsibility of the Company.

### **LRQA's Opinion**

Based on LRQA's approach nothing has come to our attention that would cause us to believe that the Company has not, in all material respects:

- Met the requirements of the criteria listed above; and
- Disclosed accurate and reliable social data as summarized in Table 1 below.

The opinion expressed is formed on the basis of a limited level of assurance<sup>5</sup> and at the materiality of the professional judgement of the verifier.

#### LRQA's Approach

LRQA's assurance engagements are carried out in accordance with ISAE3000 (Revised). The following tasks were undertaken as part of the evidence gathering process for this assurance engagement:

- Auditing the Company's data management systems to confirm that there were no significant errors, omissions or misstatements in the report. We did this by reviewing the effectiveness of data handling procedures, instructions and systems, including those for internal verification.
- Interviewing with those key people responsible for compiling the data and drafting the report.
- Sampling datasets and traced activity data back to aggregated levels;
- Interviewing and verification were conducted remotely via Microsoft Teams.
- Verifying the historical data and records associated with Lost-Time Injuries Frequency Rate, Number of fatalities in work-related accidents for the fiscal year 2025.

#### **Observations**

The Company are expected to improving the reporting and management systems to achieve more effective management of the social data.

## LRQA's Standards, Competence and Independence
